Planning Board—Amendments to Maps; Effectiveness

AN ACT

To amend section 20 of Act No. 213 of May 12, 1942, as amended.

Be it enacted by the Legislature of Puerto Rico:

Section 1.—Section 20 of Act No. 213 of May 12, 1942, as amended,⁶⁷ is hereby amended to read as follows:

Section 20.—Effectiveness of Regulations.—

All regulations and amendments thereto adopted by the Board and approved by the Governor shall take effect thirty (30) days after the approval thereof. Instead of the total publication thereof, the Board may notify the public that the regulations and amendments thereto have been approved, publishing a general description of the provisions which chiefly interest or affect the public in one or more newspapers of general circulation in Puerto Rico, for the knowledge of the interested persons. Provided, that the zoning maps approved and adopted by the Board shall form an integral part of and be conjointly effective with the zoning regulations already adopted by the Board and duly approved by the Governor; Provided, further, That the zoning maps adopted by the Board shall, after they have been signed by the Governor, take effect thirty (30) days following the date on which they were first posted to the public at the city halls of the towns affected; Provided, further, That the Board shall, through publication of an announcement for three (3) consecutive days in a newspaper of general circulation in the Island, publicly make known the adoption of the zoning maps, the posting of said maps at the pertinent city halls, and the existence of said maps in the office of the Secretary of the Board.

The amendments to the adopted Zoning Maps which the Board may subsequently approve shall also be made known to the public through the proceeding provided in this section for the Zoning Maps; Provided, however, That in these cases the publication of the announcement in the press shall be made only once in a newspaper of general circulation in the Island. Once an amendment to a Zoning Map is approved by the Board, there shall not be needed the approval and signature of the Governor thereto and same shall take effect (30) days after its publication in a newspaper of general circulation in Puerto Rico, subject to the provisions of Section 20A of this Act.⁶⁸

Excise Taxes—Boxing Programs; World Championships; Exemption

AN ACT

To amend subsection (c) of section 41 of Act No. 2, approved January 20, 1956, as amended, known as the Excise Act of Puerto Rico.

Be it enacted by the Legislature of Puerto Rico:

Section 1.—Subsection (c) of section 41 of Act No. 2, approved January 20, 1956, as amended,⁶⁹ is hereby amended to read as follows:

“Section 41.—PUBLIC SHOWS.

(c) *Shows Not Taxed.* The tax on shows shall not apply to:

(5) public shows held by bona fide nonprofit organizations registered as such in the Department of State of Puerto
