JOINT RESOLUTION

To provide the appropriations for the regular operating expenses for fiscal year 1995-96 of programs under various government agencies and instrumentalities of the Executive, Legislative and Judicial Branches.

STATEMENT OF MOTIVES

Budgeting is a dynamic process which involves a constant evaluation of four basic aspects of sound fiscal administration: (1) the government's priorities and programmatic commitments to adequately provide for the needs of society, (2) the procedures to be undertaken to attain the same, (3) the existing government programs whose obligation is to develop and establish such priorities and objectives, (4) the available resources to finance the established priorities (tax collections and debentures).

The Joint Resolution of the General Expense Budget of the Government of Puerto Rico is the instrument which depicts the distribution of public resources to the various programs destined to provide the required services to the people and to solve the problems of society. This distribution represents the priorities the Government assigns to situations, problems and needs of the people.

Precisely, recognizing that the citizen is at the same time the owner of the government and its most important client, and minding the changes and trends in budgeting processes at national and world levels, new approaches to budgeting have been adopted, oriented towards results (being accountable), quality of services, productivity and client satisfaction. As part

of this trend direct service programs to clientele have been prioritized, in lieu of administrative and organizational structures at the central government level. Importance is thus given to those who, in the last instance, are responsible for making the operational policy, reaching objectives and directly attending the clients, applying resources to the true needs of the people and increasing client satisfaction with the service the government has to provide, with no excessive costs involved.

To reach this objective, a new order of priorities has been established, redistributing resources from low priority programs and activities to those of greater importance and priority, at their true cost. Within this practice, budget appropriations are justified by the program benefit to clients and the solution of problems they provide, based on their objectives and effects.

Other circumstances contributing to the changing perspectives in budgeting have been the programmatic reforms incorporated by this Government, in response to the people's claim for a better quality of life. Among these, may be listed the Tax Reform, which returns \$400,000,000 to the people; the Health Reform, which empowers the citizen to choose the medical services of their preference; the Educational Reform through the establishment of community schools, providing the power and resources to take care of their needs to schools themselves; and the Judicial Reform, expanding the needs and extending procedural justice to all citizens.

Taking the above into account, the General Budget Joint Resolution for fiscal year 1995-96 includes modifications in terms of presentation and contents, in comparison to the previous traditional presentation, itemizing the program appropriations, number of the same, the agency it belongs to, and the corresponding appropriation.

Be it resolved by the Legislature of Puerto Rico:

Section 1.—The following sums or the portion thereof needed to carry out the purposes itemized below, are hereby appropriated, from unencumbered funds in the Commonwealth Treasury, for regular operating expenses for the fiscal year

ending June 30, 1996, of the programs and agencies which comprise the Executive, Judiciary and Legislative Branches:

Section 2.—When required in the best interests of the service, the Director of the Office of the Budget and Management may authorize the transfer of sums between the budget appropriation items of the same body of the Government of Puerto Rico, including the allocations provided to the Government Enterprises, excepting the transfer of funds appropriated for operating expenses of the programs of the bodies which comprise the Departments and Umbrella Agencies, to increase the appropriations to the secretarists or directive units of said Department or Umbrella Agencies.

Likewise, the transfer of funds consigned for the following purposes is excluded:

a. Payment of principal and interest of public and other administrative debts authorized by the Legislature; or for financing plans approved by the Government Development Bank.

b. Payment of water, power, telephone and other services provided by public instrumentalities.

c. Payment of obligations established by Law.

Under no circumstances shall the transfer of funds have the effect of postponing the payment of obligations which commit the resources of future budgets beforehand.

Funds shall not be transferred to award contracts or assume obligations beyond the fiscal year and, as a result, commit the resources of subsequent fiscal years.

The Office of the Budget and Management shall submit to the Ways and Means Committee of the House of Representatives and the Senate, through the Office of the Secretary of both Bodies, a report on the transfers made.

The report shall be submitted every two months, no later than fifteen (15) calendar days after the end of the period. The report shall consist of two parts: the transfers within items of the same body; and the transfers between appropriations items

of the fiscal unit, or between bodies and programs which comprise an umbrella agency. The reports shall include the following information:

a. Itemized transfer of funds within the same body and within the fiscal unit. Indicate which of the budget appropriation items as authorized by the General Budget Joint Resolution are affected or incremented.

Section 4.—When accounting the appropriations provided in this Joint Resolution, the Office of the Budget and Management may withhold the sum corresponding to the payment of bonds and fidelity insurance as applicable. To expedite the process of contracting and paying these insurance policies, said sums may be transferred directly to the Department of the Treasury.

Section 5.—The balances or remainders of the appropriations provided in this Joint Resolution shall be available according to the provisions of Act No. 230 of July 23, 1974, as amended, known as the "Puerto Rico Government Accounting Act"

Section 6.—Salaries of employees and officials shall be paid according to the provisions of the law known as "Uniform Compensation Act" or of any uniform compensation plan approved subsequently by the Legislature and in keeping with the rules and regulations of the Central Office of Personnel Administration, chargeable to appropriations for the departments and agencies consigned in this Joint Resolution, or any other appropriations authorized for these purposes.

Section 7.—The agencies, with the prior approval of the Governor or the Director of the Office of the Budget and Management, are hereby authorized to enter into agreements with other agencies and/or the municipalities to provide services on a contractual basis or the matching of municipal funds, and those consigned in this Joint Resolution.

Section 8.—The Director of the Office of the Budget and Management and the Secretary of the Treasury, are hereby authorized to establish special accounts and to advance funds chargeable to said accounts, for the payment of services to the Electric Power Authority, the Aqueduct and Sewer Authority, the Telephone Authority, the Communications Authority, the Public Buildings Authority and the Transportation and Printing Services of the General Services Administration, and the insurance premiums of the programs of the State Insurance Fund Corporation and of the Department of Labor and Human

Resources (unemployment insurance; disability insurance; chauffeur[]s insurance).

Public corporations and enterprises that provide services to the Government, are hereby directed to promptly and efficiently submit invoices and collection documents and the user agencies shall verify and diligently proceed with the payment of the invoices received. The Department of the Treasury shall watch over the establishment by both the user agencies and the public corporations of the needed procedures to liquidate the invoiced services chargeable to the accounts and advances provided, promptly and correctly. The Secretary of the Treasury is also authorized to make adjustment among accounts, obligations and advances of the various agencies and to withhold funds from said accounts, to ensure the prompt payment of public services.

Section 9.—Private nonprofit entities which receive funds from the Government of Puerto Rico shall submit a plan on the proposed use of the appropriation to the Office of the Budget and Management within thirty (30) days following the approval thereof, and an annual report on the effectiveness and use of those resources according to said plan, on or before August 28 of each year, until the appropriation is used up.

Section 10.—This Resolution shall be known as the "General Budget Joint Resolution for 1996".

Section 11.—This Joint Resolution shall take effect July 1, 1995.
