SECTION 5.—That this Act shall take effect from and after its approval.

Approved March 9, 1905.

AN ACT

TO CONTINUE THE WORK OF THE COMMISSION FOR THE SUPPRESSION OF ANEMIA IN PORTO RICO, AND MAKING APPROPRIATION THEREFOR.

Be it enacted by the Legislative Assembly of Porto Rico:

SECTION 1.—The sum of fifteen thousand dollars, or so much thereof as may be necessary, is hereby appropriated, out of any moneys in the Treasury not otherwise appropriated, for the purpose of continuing the work of suppressing the disease known as uncinariasis in Porto Rico.

SECTION 2.—The said appropriation shall be expended under the direction of the Governor of Porto Rico for the necessary expenses of carrying on the work, establishing hospitals, purchasing medicines and supplies, and the employment of the necessary physicians, nurses and other employees.

SECTION 3.—The Governor is hereby authorized, if he deems best, to use as a hospital, either or both of the barracks constructed at Humacao and Jayuya, for the convict labor on the road work.

SECTION 4.—This act shall take effect from and after its passage.

AN ACT

MAKING APPROPRIATIONS FOR THE NECESSARY EXPENSES OF CARRYING ON THE GOVERNMENT OF PORTO RICO, FOR THE FISCAL YEAR ENDING JUNE THIRTIETH, NINETEEN HUNDRED AND SIX, AND FOR OTHER PURPOSES.

Be it enacted by the Legislative Assembly of Porto Rico:

SECTION 1.—That the following sums be, and the same are hereby appropriated, out of any money in the treasury not otherwise appropriated, in full compensation for the services of the fiscal year ending June thirtieth, nineteen hundred and six, for the objects hereinafter expressed, namely:

LEGISLATIVE.

LEGISLATIVE ASSEMBLY OF PORTO RICO.

Salaries, Executive Council: For five members, at three thousand dollars, per annum, each, fifteen thousand dollars; chief clerk, per annum, two thousand dollars; interpreter and translator, per annum, two thousand two hundred dollars; assistant clerk and disbursing officer, per annum, one thousand eight hundred dollars; stenographer, per annum, one thousand four hundred dollars; messenger and janitor, per annum, four hundred and eighty dollars; temporary employees during the session of the Legislative Assembly: sergeant-at-arms, for one hundred and twenty days at four dollars per day, four hundred and eighty dollars; journal clerk, for sixty days at five dollars per day, three hundred dollars; committee clerk, for sixty days at five dollars per day, three hundred dollars; three committee clerks, for twenty days at five dollars per day each, three hundred dollars; translation—so much thereof as may be necessary, one thousand dollars; enrolling and engrossing, or as much thereof as may be necessary, three hundred and sixty dollars; in all, twenty five thousand six hundred and twenty dollars.

Contingent Expenses, Executive Council: For legislative printing, seven hundred and fifty dollars; incidental expenses, seven hundred and fifty dollars; in all, one thousand five hundred dollars.

Printing and Publication of Laws: For printing and binding the laws of Porto Rico, the Journal of the Executive Council and the Annual Register, to be expended by the disbursing officer of the Legislative Assembly, under the direction of the Secretary of Porto Rico, upon the approval and authority of the Executive Council, one thousand five hundred dollars.

Salaries, House of Delegates: For thirty-five members, for sixty days at five dollars per day each, ten thousand five hundred dollars; secretary, per annum, one thousand eight hundred dollars; interpreter and translator, per annum, one thousand eight hundred dollars; stenographer and typewriter, per annum, one thousand five hundred dollars; sergeant-at-arms, per annum, one thousand dollars; typewriter-clerk, for office of the Speaker, per annum, eight hundred dollars; messenger, per annum, three hundred and sixty-five dollars; temporary employees during the session of the Legislative Assembly: Three translators, for sixty days at three hundred and fifty dollars each, one thousand and fifty dollars; temporary clerks, for sixty days at not to exceed

four dollars per day each, one thousand two hundred dollars; Two messengers, for sixty days at sixty dollars each, one hundred and twenty dollars; in all, twenty thousand one hundred and thirty-five dollars.

Contingent Expenses, House of Delegates: For legislative printing, two thousand dollars; incidental expenses, five hundred dollars; purchase of books for library, furniture and equipment, four hundred dollars; mileage of members, one thousand dollars; in all, three thousand nine hundred dollars; provided that all legislative printing for the Executive Council and the House of Delegates and the printing of the laws of Porto Rico, including the journal of the Executive Council and the annual register, shall be done by or under the direction of the printing office of the Insular Government.

EXECUTIVE

OFFICE OF THE GOVERNOR.

Salaries, Office of the Governor: For the Governor, eight thousand dollars; private secretary to the governor, one thousand eight hundred dollars; stenographer and typewriter, one thousand and five hundred dollars; door-keeper, five hundred dollars; in all, eleven thousand eight hundred dollars.

Contingent Expenses, Office of the Governor: For blank books, stationery, furniture, office supplies, cablegrams, and necessary incidental expenses, one thousand two hundred dollars.

INSULAR POLICE OF PORTO RICO.

Salaries, Insular Police: For the Chief, whose military title shall be that of Lieutenant-Colonel, two thousand seven hundred and fifty dollars; assistant chief, whose military title shall be that of major, two thousand dollars; six captains, at one thousand five hundred dollars each, nine thousand dollars; captain and paymaster, one thousand eight hundred and fifty dollars; paymaster's clerk, one thousand dollars; first lieutenant and adjutant, one thousand dollars; six first lieutenants, at one thousand dollars each, six thousand dollars; second lieutenant and bandmaster, nine hundred dollars; seven second lieutenants, at nine hundred dollars each, six thousand three hundred dollars; twenty sergeants, at six hundred dollars each, twelve thousand dollars; seventy-five corporals, at four hundred and eighty dollars each, thirty-six thousand dollars; six hundred and fifty guardsmen, at three hundred and sixty dollars each, not more than five of whom may be detailed on special detective service and whose compensa-

tion for such service shall be at the rate of four hundred and eighty dollars per annum, while so employed; in all, a sum for salaries of guardsmen not to exceed two hundred and thirty-four thousand six hundred dollars, two hundred and thirty-four thousand six hundred dollars; in all, three hundred and thirteen thousand four hundred dollars.

Contingent Expenses, Insular Police: For transportation, seven thousand five hundred dollars; stabling, keeping, shoeing, veterinary attendance and medicine for horses, two thousand five hundred dollars; rent of quarters, seven thousand dollars; furniture and repairs to same, five hundred dollars; postage for official correspondence, one thousand dollars; incidental expenses, one thousand dollars; in all eighteen thousand five hundred dollars.

OFFICE OF THE SECRETARY.

Salaries, Office of the Secretary: For the Secretary, four thousand dollars; Assistant Secretary, two thousand five hundred dollars; chief clerk, two thousand dollars; one clerk, one thousand eight hundred dollars; two clerks at one thousand six hundred dollars each, three thousand two hundred dollars; three clerks at one thousand four hundred dollars each, four thousand two hundred dollars; five clerks at one thousand two hundred dollars each, six thousand dollars; three clerks at one thousand dollars each, three thousand dollars; two messengers at three hundred and sixty dollars each, seven hundred and twenty dollars; in all, twenty-seven thousand four hundred and twenty dollars.

Salaries, Bureau of Printing and Supplies: For chief of bureau and public printer, one thousand six hundred dollars; chief clerk, one thousand six hundred dollars; accountant and clerk, nine hundred dollars; in all, four thousand one hundred dollars.

Contingent Expenses, Bureau of Printing and Supplies: For purchase of stationery and supplies and the execution of printing and binding for the Insular legislature and the several offices, bureaus and departments of the government, including the hire of necessary temporary help, five thousand dollars; Provided, that the cost of all stationery and supplies furnished to, and of all printing and binding performed, for the Insular legislature or any office, bureau or department of the government shall be paid by the legislature or department on whose account such articles are furnished or work performed from the appropriation provided for

such expenditures, and the payment so made shall be covered into the appropriation of the Bureau of Printing and Supplies for the purchase of stationery and supplies, etc., so as to be available for further use by said Bureau. Purchase of machinery, type and other articles that may be required for the better equipment of the Bureau for economical and efficient work, two thousand five hundred dollars; in all, seven thousand five hundred dollars.

It is hereby provided that the Bureau of Printing and Supplies shall constitute a distinct Bureau, and the Governor, with the approval of the Executive Council, is authorized and empowered to place it under and make it a part of that one of the five executive departments created by the Organic Act of Porto Rico as in his opinion will be for the best interests of the Government of Porto Rico.

DEPARTMENT OF THE INTERIOR.

SECTION 2.—The respective amounts herein appropriated for salaries of internal revenue officers, and for chiefs of divisions of bureaus, chief clerks, clerks and subordinate employees, in the several executive departments of the Insular Government, shall

be deemed and held to be limitations, subject to which the heads of the respective departments may fix the salaries of such employees in such amounts as may be approved by the Executive Council.

SECTION 3.—When, in the opinion of the Governor, the interests of the public service require it, he may authorize transfers from appropriations provided for any particular department of the Insular Government to appropriations of like general character provided for the same department, and may also, in like manner, authorize transfers from one sub-head of appropriations to another sub-head.

SECTION 4.—All the materials which may be purchased under the appropriations provided in this Act, the value of which exceeds one thousand dollars, shall be purchased on public bids where such purchases are made in Porto Rico, and where such purchases are made in the United States, they shall be made on competitive bids solicited by circulars sent to well known dealers.

SECTION 5.—Any moneys received by the Insane Asylum from pay patients shall be deposited with the Treasurer of Porto Rico to the credit of the appropriation "Contingent Expenses, Insane Asylum," and shall be available for expenditure during the fiscal year in which it is received.

AN ACT

MAKING APPROPRIATIONS TO SUPPLY DEFICIENCIES IN APPROPRIATIONS FOR CARRYING ON THE GOVERNMENT OF PORTO RICO FOR THE FISCAL YEAR ENDING JUNE 30, 1905 AND PRIOR YEARS, AND FOR OTHER PURPOSES.

Be it enacted by the Legislative Assembly of Porto Rico:

SECTION 1.—That the following sums be, and the same are hereby, appropriated out of any money in the treasury not otherwise appropriated, to supply deficiencies in the appropriations for the fiscal year ending June 30, 1905, and for prior years, for the objects hereinafter stated, namely: Salaries, Executive Council, 1904-1905: For amount required to pay for the services of two additional clerks in the office of the Executive Council, at the rate of four dollars per day, each, for thirty days, two hundred and forty dollars; for one messenger for sixty days, at one dollar per day, sixty dollars; in all, three hundred dollars. Extra compensation for engrossing and enrolling clerks, Executive

Council, 1904-1905: For estimated amount necessary to pay for the services of clerks employed in the Executive Council and in the Executive Departments of the Insular Government, working outside of regular office hours in engrossing and enrolling laws which may be passed by the Legislative Assembly at the present session, at rates not exceeding fifty cents per hour, or so much thereof as may be necessary, five hundred dollars. Contingent Expenses, Executive Council, 1904-1905: For printing and incidental expenses, three thousand dollars. Salaries, House of Delegates, 1904-1905: For amount required to pay the services of two additional clerks in the office of the House of Delegates, at the rate of four dollars per day, each, for thirty days, two hundred and forty dollars. Extra compensation for engrossing and enrolling clerks, House of Delegates, 1904-1905: For estimated amount necessary to pay the services of clerks employed in the House of Delegates, working outside of regular office hours, at rates not exceeding fifty cents per hour, or so much thereof as may be necessary, one thousand dollars. Expenses of Election in Porto Rico, 1904-1905: For amount required to pay for expenses actually and necessarily incurred on account of the election in Porto Rico held on November 8, 1904, and now due, for services and supplies, in excess of the appropriation provided in the general appropriation act approved March 10, 1904, as ascertained by the Committee on Elections of the Executive Council, twenty-eight thousand seven hundred and fourteen dollars and fifty cents; and an additional amount of one thousand and fifty-seven dollars and eleven cents for reimbursement to appropriation, "Miscellaneous Expenditures, subject to the approval of the Governor," 1904-1905, for amount advanced; in all, twenty-nine thousand seven hundred and seventy-one dollars and sixty-one cents, or so much thereof as may be necessary. Contingent Expenses, Insular-Police, 1904-1905: For amount necessary to reimburse the appropriation, "Miscellaneous Expenditures, subject to the approval of the Governor," 1904-1905, for amount advanced for purchase of horses, two thousand three hundred and fifty dollars; For incidental expenses, including stationery and supplies necessary for the various posts throughout the Island, two thousand five hundred dollars; for postage necessary for the correspondence between police headquarters and the post, two hundred dollars; for stabling and keeping of horses, one thousand dollars; in all, six thousand and fifty dollars, or so much thereof as may be necessary. Contingent Expenses, Office of the Treasurer of Porto Rico, 1904-1905: For furniture, printing,

stationery supplies, and incidental expenses, one thousand five hundred dollars. Contingent Expenses, Bureau of Public Works, 1904-1905: For office supplies, including printing and supplies furnished by the Bureau of Printing and Supplies, and for postage, seven hundred dollars. Maintenance and repair of public buildings, 1904-1905: For preservation, care, and repair of public buildings, other than the Executive Mansion, five thousand dollars; for amount necessary to reimburse the appropriation "Miscellaneous Expenditures, subject to the approval of the Governor," 1904-1905, for amount advanced, one thousand five hundred dollars; in all, six thousand five hundred dollars. Salaries, Office of the Commissioner of Education, 1904-1905: For one clerk, at one thousand two hundred dollars per annum, from March 1st to June 30th 1905, four hundred dollars; two clerks, at nine hundred dollars per annum, each, from March 1st to June 30th, 1905, six hundred dollars; in all, one thousand dollars. Contingent Expenses, Office of the Commissioner of Education, 1904-1905: For blank books, stationery, office supplies and incidentals, five hundred dollars. Expenses of Printing Motion and Brief in Gonzalez case before the Supreme Court of the United States, 1903-1904: For expenses of printing motion and brief in the Gonzalez case before the Supreme Court of the United States, ninety-eight dollars. Payment of moieties to Informers, 1904-1905: For amount required to pay informers one-half of the fines collected from defrauders of the revenues of Porto Rico, as authorized by Section 366 of the Political Code approved March 1, 1902, fifty dollars. For payment of the claim of the Western Union Telegraph Company: For transmission of cablegrams and messages, at Washington, D. C., pertaining to the Island of Porto Rico, from January 19, 1899, to November 13, 1900, ninety-eight dollars and ninety-one cents. Study and suppression of disease known as "Anemia" in Porto Rico: For the payment of the salary of Dr. Pedro Gutierrez Igaravidez, from October 1, 1904, to December 31, 1904, being for three months, at one hundred and fifty dollars per month, as member of the Anemia Commission, authorized by the Act approved February 16, 1904, four hundred and fifty dollars. Fees and traveling expenses of former "Comisionados de Apremio" on taxes in arrears prior to July 1, 1901, condoned by Act of the Legislative Assembly of Porto Rico, approved March 12, 1903, two thousand dollars, or so much thereof as may be necessary. For expenses of advertising and sale of real property bid in by The People of Porto Rico in the enforcement of the collection of delinquent taxes upon property, one thousand five

hundred dollars, or so much thereof as may be necessary. That the Auditor of Porto Rico is hereby authorized and directed to certify for payment the following amounts found due to the employees of the Printing office connected with the Auditor's office, for extra work performed at night and outside of regular hours by the said employees in printing the official ballots used in the election in Porto Rico held in November, 1904, and other official printing connected with said election, and for extra work performed at night and outside of regular hours in completing official printing urgently required by the several departments of the Insular Government. To R. G. Conover, chief of division of printing and supplies, for 194 hours of extra work, at 50 cents per hour, ninety-seven dollars. To Thomas Green, public printer, for 582 hours of extra work, at 50 cents per hour, two hundred and ninety-one dollars; in all, three hundred and eighty-eight dollars; to be paid from the appropriation for "Contingent Expenses, Office of the Auditor," 1904-1905, sub-head, "purchase of stationery and stationery supplies for the printing office and the incidental expenses connected therewith," etc. Fees, and mileage of Jurors, United States District Court, 1904-1905: For fees and mileage of jurors in attendance upon the United States District Court of Porto Rico, one thousand dollars. Salaries, Supreme Court of Porto Rico, 1904-1905: For one typewriter, from July 1 to July 17, 1904, at eight hundred dollars per annum, thirty-seven dollars and seventy-eight cents; for two copyists, from July 1 to July 17, 1904, at four hundred and eighty dollars per annum, each, forty-five dollars and thirty-four cents; for one messenger, from July 1 to July 17, 1904, at three hundred and sixty dollars per annum, seventeen dollars; in all, one hundred dollars and twelve cents. Salaries, District Court of San Juan, 1904-1905: For one second deputy-marshal and janitor, from January 1 to June 30, 1905, at three hundred dollars per annum, one hundred and fifty dollars. For salaries to be paid Mr. Louis Velez Lopez as temporary file keeper of the District Court of San Juan, from December 8, 1902, to March 4, 1903, at fifty dollars per month, one hundred and forty-five dollars. Salaries, District Court of Ponce, 1904-1905: For one deputy secretary, from January 1 to June 30, 1905, at seven hundred and twenty dollars per annum, three hundred and sixty dollars; for one second deputy-marshal and janitor, from January 1 to June 30, 1905, at three hundred dollars per annum, one hundred and fifty dollars; in all, five hundred and ten dollars. Salaries, District Court of Mayagüez, 1904-1905: for one deputy secretary, from January 1 to June 30,

1905, at seven hundred and twenty dollars per annum, three hundred and sixty dollars; for one second deputy-marshal and janitor, from January 1 to June 30, 1905, at three hundred dollars per annum, one hundred and fifty dollars; in all, five hundred and ten dollars. Salaries District Court of Arecibo, 1904-1905: for one second deputy-marshal and janitor, from January 1, to June 30, 1905, at three hundred dollars per annum, one hundred and fifty dollars. Salaries District Court of Humacao, 1904-1905: For one second deputy-marshal and janitor, from January 1 to June 30, 1905, at three hundred dollars per annum, one hundred and fifty dollars. Salaries, District Court of Guayama, 1904-1905: for one second deputy-marshal and janitor, from January 1 to June 30, 1905, at three hundred dollars per annum, one hundred and fifty dollars. Salaries, District Court of Aguadilla, 1904-1905: for one second deputy-marshal and janitor, from January 1 to June 30, 1905, at three hundred dollars per annum, one hundred and fifty dollars. Salaries, Deputy District Marshals, Insular Courts 1904-1905: For one deputy-marshal, each, for the district courts of San Juan, Ponce, and Mayagüez, from January 1 to June 30, 1905, at one thousand dollars per annum, one thousand five hundred dollars; for one deputy marshal, each, for the district courts of Arecibo, Humacao, Guayama, and Aguadilla, from January 1 to June 30, 1905, at seven hundred and twenty dollars, each, per annum, one thousand, four hundred and forty dollars; in all, two thousand, nine hundred and forty dollars. Salaries, Municipal Courts, 1904-1905: for one deputy-marshal, each, for the municipal courts of San Juan, Ponce, Mayagüez, Arecibo, Humacao, Caguas, Cayey, Guayama, Lares, Utuado and Aguadilla from January 1 to June 30, 1905, at four hundred and eighty dollars per annum, each, two thousand six hundred and forty dollars. Contingent Expenses, Insular Courts, 1904-1905: For incidental expenses of the Supreme Court, including the offices of the Secretary and Fiscal, four hundred and ten dollars; for incidental expenses of the district courts, two thousand five hundred and twenty dollars; for furniture, two thousand dollars; for stationery and incidental expenses of municipal courts, six hundred dollars; for postage for the district courts, two hundred and sixty-five dollars; for postage for the municipal courts, one hundred and fifty dollars; for traveling expenses of marshals, five thousand dollars; in all, ten thousand nine hundred and forty-five dollars, provided that no payment shall be made on account of hire of coaches and no payment on account of hire of horses except when

the said horses are hired for the transportation of prisoners. Payment of Judgment of the District Court of San Juan: For amount required to pay to the religious community known as the Servants of Mary, of San Juan, the judgment of the District Court of San Juan in favor of said religious community, affirmed by the Supreme Court of Porto Rico, being a judgment on a claim against the late Diputación Provincial, transferred to the District Court of San Juan, pursuant to the provisions of paragraph VI of General Order No. 84, creating the Commission on Claims against the late Diputación Provincial, issued by order of the Military Governor of Porto Rico on April 18, 1900, fifty dollars, in accordance with the affirmance of the Supreme Court of Porto Rico.

SECTION 2.—This Act shall take effect from and after its passage.

AN ACT

TO PUT IN FORCE FOR A PERIOD OF TWO YEARS THE ACT OF MARCH 12, 1903, REGARDING THE REGISTRATION OF BIRTHS OF CHILDREN.

Be it enacted by the Legislative Assembly of Porto Rico:

SECTION 1.—The Act of March 12, 1903, entitled: "An Act regarding the registration of births of children" is again put in force for a period of two years from March 20, 1905, to May 20, 1907.

SECTION 2.—The Secretary of Porto Rico is charged with the faithful enforcement and operation of this Act.

SECTION 3.—This Act shall take effect on and after March 20, 1905.

AN ACT

TO PURCHASE THE PORTRAIT OF MAJOR GENERAL JOHN R. BROOKE AND TO APPROPRIATE ALL NEEDED FUNDS THEREFOR.

Be it enacted by the Legislative Assembly of Porto Rico:

SECTION 1.—The sum of four hundred dollars (\$400) or so much thereof as may be necessary is hereby appropriated out of any funds in the Insular Treasury not otherwise appropriated, to purchase the portrait of Major General John R. Brooke, now in possession of Mr. F. Oller.

SECTION 2.—That said portrait shall be placed in the Executive Mansion, together with the collection of portraits of former Governors.

SECTION 3.—This Act shall take effect on and after its approval.

AN ACT

PROVIDING FOR THE ADJUDICATION OF THE CLAIM OF MR. MANUEL J. CALDERON OF A CERTAIN SUM OF MONEY AS COMPENSATION FOR SERVICES RENDERED AS ACTING SECRETARY OF THE ARECIBO DISTRICT COURT, FOR TEN MONTHS AND FOURTEEN DAYS.

Be it enacted by the Legislative Assembly of Porto Rico:

SECTION 1.—The Auditor of Porto Rico is hereby authorized to investigate the claim of Manuel J. Calderon for the sum of seven hundred and twenty two dollars and twenty cents (\$722.20) as compensation for services rendered as Acting Secretary of the Arecibo District Court, for ten months and fourteen days, for which time he claims to have held such position, and if the Auditor approve the said claim, he shall issue a warrant for its payment.

SECTION 2.—The amount of seven hundred twenty-two dollars and twenty cents (\$722.20), or so much thereof as may be necessary, is hereby appropriated out of any money in the Treasury not otherwise appropriated, for the settlement of this claim.

SECTION 3.—This Act shall take effect from and after its passage.
