AN ACT

TO PROVIDE FOR THE CONSTRUCTION OF A BRIDGE OVER THE NAGUABO RIVER.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—That the Commissioner of the Interior is hereby empowered to construct a bridge over the Naguabo River. Said bridge shall be built in accordance with the plan which is in the hands of the municipality of Naguabo, which plan shall be submitted to the Commissioner of the Interior for modification or approval. Said work shall be carried out in the shortest time possible by means of public auction. Should said auction be advertised twice and no bids be received, the work shall be done by administration.

Section 2.—That for the purpose of complying with this Act the sum of eight thousand dollars (\$8,000), or such part thereof as may be necessary, is hereby appropriated from any funds in the Treasury not otherwise appropriated; *Provided*, That the Commissioner of the Interior is hereby authorized to receive from the municipality of Naguabo the sum of two thousand dollars contributed by said municipal corporation to complete the ten thousand dollars which the work will cost.

Section 3.—That all laws or parts of laws in conflict herewith are hereby repealed.

Section 4.—That this Act shall take effect immediately after its approval.

AN ACT

AUTHORIZING THE MUNICIPALITY OF ARECIBO TO EXPEND IN WORKS OF PUBLIC UTILITY A CERTAIN SUM REMAINING AS A SURPLUS FROM THE PRECEDING FISCAL YEAR.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—That the municipality of Arecibo is hereby empowered to expend the sum of three thousand eight hundred and eighty-six dollars and thirty-three cents (\$3,886.33), which is 25 per cent of the surplus of the appropriations of the said municipality for the fiscal year 1911–12, for the acquisition and installation of water meters and to improve the aqueduct of said city.

Section 2.—That no appropriation shall be made from said sum for the expenses of administration to which section 83 of the Municipal Law refers.

Section 3.—That the municipal ordinance making the appropriations hereby authorized shall be drawn up in accordance with the provisions of section 85 of the Municipal Law, relative to budgets.

Section 4.—That this Act shall take effect upon its approval.

AN ACT

MAKING APPROPRIATIONS FOR THE NECESSARY EXPENSES OF CARRYING ON THE GOVERNMENT OF PORTO RICO FOR THE FISCAL YEAR ENDING JUNE THIRTIETH, NINETEEN HUNDRED AND FOURTEEN, AND FOR OTHER PURPOSES.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—That the following sums, or so much thereof as may be respectively necessary, are hereby appropriated out of any funds in the Treasury not otherwise appropriated, in full compensation for the services of the fiscal year ending June thirtieth, nineteen hundred and fourteen, for the objects hereinafter expressly named:

Section 3.—Any moneys received by the Insane Asylum from pay patients shall be deposited in the Treasury of Porto Rico to the credit of the appropriation "Contingent Expenses, Insane Asylum," being divided equally between the subhead "Subsistence" and the subhead "Clothing, Bedding, etc.," and shall be available for expenditure during the fiscal year in which it is received.

Section 4.—Any moneys received by the Girls' Charity School from the sale of articles made by the girls shall be deposited in the Treasury of Porto Rico in a special trust fund, to be known as "Sale of Articles, Girls' Charity School, Trust Fund," and shall be available for the purchase of raw material for future similar work and for the payment of small amounts to the girls upon leaving the school, which payment shall be in accordance with such general rules as the Director

of Labor, Charities and Correction shall prescribe to govern such cases.

Section 5.—Any moneys received by the Boys' Charity School from the sale of articles made and work done inside or outside of the institution by the boys shall be deposited in the Treasury of Porto Rico in a trust fund to be known as "Sale of Articles and Work done, Boys' Charity School, Trust Fund," and shall be available for the purchase of raw material for future similar work and for the payment of small amounts or the presentation of instruments and tools of arts and trades to the boys upon leaving the school, which payment or presentation shall be in accordance with such general rules as the Director of Labor, Charities and Correction shall prescribe to govern such cases; Provided, That 50 per cent of the receipts from band concerts shall be placed in a special trust fund, known as "Recreation Fund," to be expended for library books, athletics and amusements.

Section 6.—Any moneys received by the Penitentiary from the sale of articles made by the prisoners therein shall be deposited in the Treasury of Porto Rico in a trust fund, to be known as "Sale of Articles, Penitentiary Trust Fund," and shall be available for the purchase of raw materials for future similar work.

Section 7.—The Director of Labor, Charities and Correction is hereby authorized to determine whether refrigated meat may or may not be supplied to institutions under his direction.

Section 8.—For the salary of female teacher for the Industrial School of Canas, Ponce, which is maintained with funds of the Porto Rico Benevolent Society, at \$675 per annum; for salary of an English teacher in the Ponce Lyceum, at \$750 per annum, and for salary of an English teacher in the Robinson Training and Industrial Institute, at Hatillo, at \$500 per annum, there is hereby appropriated out of any moneys in the Treasury, not otherwise appropriated, the sum of \$1,925 per annum. The Auditor of Porto Rico shall have the right to inspect the books of the said institutions.

Section 9.—The respective amounts herein appropriated for salaries of internal revenue officers, and for chiefs of divisions, of bureaus, chief clerks, clerks, and subordinate employees in the several departments of the Insular Government, whose salaries are above twelve hundred dollars (\$1,200) per annum, shall be deemed and held to be limitations, subject to which the heads of the respective departments may fix the salaries of such employees in such amounts as may be approved by the Executive Council; *Provided*, *however*, That no

salaries affected by this section be fixed below twelve hundred dollars (\$1,200).

Section 10.—All laws or parts of laws in conflict with this Act are hereby repealed.

AN ACT

PROVIDING FOR THE CONSTRUCTION OF THE ROAD FROM MARTIN PENA TO BAYAMON, AND OF A BRIDGE ON SAID ROAD.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—That there is hereby appropriated from any funds in the Treasury not otherwise appropriated, to continue the road from Martín Peña to Bayamón and to construct the San Antonio Bridge on said road, the sum of seventy-five thousand dollars.

Section 2.—That the Commissioner of the Interior shall carry out said work in the shortest possible time by means of public auction. Should said auction be advertised twice and no bids be received he shall do the work by administration.

Section 3.—That all laws or parts of laws in conflict herewith are hereby repealed.

Section 4.—That this Act shall take effect immediately after its approval.

AN ACT

MAKING ADDITIONAL APPROPRIATIONS FOR THE FISCAL YEAR ENDING JUNE THIRTIETH, NINETEEN HUNDRED AND THIRTEEN, AND TO BE ALSO AVAILABLE FOR ANY NEEDED EXPENDITURES DURING THE FISCAL YEAR NINETEEN HUNDRED AND THIRTEEN AND FOURTEEN, AND FOR OTHER PURPOSES.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—That the following sums, or so much thereof as may be respectively necessary, are hereby appropriated out of any funds in the Treasury not otherwise appropriated, in full compensation for the services of the fiscal year ending June thirtieth, nineteen hundred and thirteen, and also for the fiscal year nineteen
