AN ACT

MAKING AN APPROPRIATION TO IMPROVE THE CONDITIONS OF THE LEPER COLONY OF THE ISLAND OF PORTO RICO.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—That for the purpose of providing for the construction of an artesian well or cistern, and of one or several dwelling houses for the women's department of the Leper Colony in the Island of Cabras and for such other constructions or repairs as it may be deemed advisable to make in the said institution, and also for the purpose of providing for the purchase of a launch to facilitate communication between the said island and the city of San Juan, the sum of six thousand (6,000) dollars, or as much thereof as may be necessary, is hereby appropriated out of any funds in the Insular Treasury not otherwise appropriated.

Section 2.—That this Act shall take effect from and after its approval.

AN ACT

MAKING APPROPRIATIONS FOR THE NECESSARY EXPENSES OF CARRYING ON THE GOVERNMENT OF PORTO RICO, FOR THE FISCAL YEAR ENDING JUNE THIRTIETH, NINETEEN HUNDRED AND TWELVE, AND FOR OTHER PURPOSES.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—That the following sums, or so much thereof as may be respectively necessary, are hereby appropriated, out of any funds in the Treasury not otherwise appropriated, in full compensation for the services of the fiscal year ending June thirtieth, nine-teen hundred and twelve, for the objects hereinafter expressly named:

Personnel, Bureau of Supplies, Printing and Transportation: To provide for the operation of a bureau for the purpose of furnishing supplies, printing and transportation required by the different branches of the Government, the maintenance of a "Working capital fund" is hereby authorized, and the Treasurer is hereby authorized and directed to advance from time to time. whenever so required, to the credit of said funds, out of any moneys in the Treasury not otherwise appropriated, amounts which shall not at any one time exceed a total of \$25,000; Provided, That all or any part of said "Working capital fund" may be advanced to a special disbursing officer to enable him to pay for equipment, supplies and services purchased on account of the Bureau of Supplies, Printing and Transportation, such funds to be by him accounted for under the rules and regulations prescribed by the Auditor of Porto Rico; Provided, That the moneys so advanced shall be returned to the fund from which advanced so soon as payment has been received by the Bureau of Supplies, Printing and Transportation, for the articles or services for the purchase or acquisition of which the advance was made; Provided, That the costs of furnishing all stationery, equipment and supplies, printing and binding, and transportation furnished to and provided for the Insular Legislature or any department, bureau or office of the Government, or municipality, shall be paid by the Legislature, department, bureau, office or municipality on whose account such articles are furnished or work performed, from the appropriation provided for such expenditures, to the Bureau of Supplies, Printing and Transportation, to be deposited in the "Working capital fund;" Provided, further, That payment for all services, articles and supplies furnished shall be made at the actual costs thereof, in the city of San Juan, including freight, insurance, deterioration and operating and all other expenses incident to the purchase and delivery to the Legislature, department, bureau, office or municipality ordering the same, plus not to exceed 10% additional upon such costs, to cover salaries of Chief of Bureau, clerical assistance, and miscellaneous office expenses essential to the purchase and furnishing of said/services, articles and supplies. Moneys derived from the sales of old machinery, equipment and old material of the Bureau of Supplies, Printing and Transportation shall likewise revert to the credit of said fund. From said "Working capital fund" shall be paid the salaries of the Chief of the Bureau of Supplies, Printing and Transportation and such permanent employes, at such rates and compensation as shall be authorized by the Executive Council, temporary employes, cost of equipment, and contingent expenses necessary for the maintenance of the Bureau of Supplies, Printing and Transportation.

Accounts of all transactions of said bureau shall be kept as prescribed by the Auditor, subject to monthly examination by his office, and the chief of said bureau shall render to the Auditor such monthly statements of the transactions of the bureau as the Auditor shall require; Providing, further, That a commission to be composed of a member of the Executive Council appointed by the President thereof and of two Delegates to be appointed by the Speaker of the House, shall make an investigation, at least every three months and at such other time as may be deemed advisable, of the transactions of said agency. The chief of the bureau shall furnish to said commission all the data relative to the movement and investment of the industrial capital, the aggregate amounts of all purchases and sales, the prices of the articles purchased, the balance sheet and amount of profits and names of the employes assuming the responsibility of the bureau with their respective salaries. Said commission shall have the same faculties now had by any commission of the Legislative Assembly, shall report the result of their investigations to the Governor of Porto Rico and shall submit a full report at the next session of the Legislative Assembly.

Section 5.—Any moneys received by the Boys' Charity School for the sale of articles made and work done inside or outside of the institution by the boys shall be deposited in the Treasury of Porto Rico, in a trust fund to be known as "Sale of articles and work done, Boys' Charity School, trust fund," and shall be available for the purchase of raw material for future similar work and for the payment of small amounts or the presentation of instruments and tools of arts and trades to the boys upon leaving the school, which payment or presentation shall be in accordance with such general rules as the Director of Health, Charities and Correction shall prescribe to govern such cases.

Section 6.—Any moneys received by the penitentiary from the sale of articles made by the prisoners therein shall be deposited in the Treasury of Porto Rico, in a trust fund to be known as "Sale of articles, Penitentiary, trust fund," and shall be available for the purchase of raw material for future similar work.

Section 7.—The Director of Health, Charities and Correction is hereby authorized to determine whether refrigerated meat may or may not be supplied to institutions under his direction.

Section 8.—For salary of female teacher for the Industrial School of Canas, Ponce, which is maintained with funds of the Porto Rican Benevolent Society, there is hereby appropriated out of any moneys in the Treasury, not otherwise appropriated, the sum of six hundred and seventy-five (675) dollars per annum. The Auditor of Porto Rico shall have the right to inspect the books of the said society.

Section 9.—The respective amounts herein appropriated for salaries of internal revenue officers, and for chiefs of divisions, bureaus, chief clerks, clerks, and

subordinate employes in the several departments of the Insular Government, whose salaries are above twelve hundred (1,200) dollars per annum, shall be deemed and held to be limitations, subject to which the heads of the respective departments may fix the salaries of such employes in such amounts as may be approved by the Executive Council; *Provided, however*, That no salaries affected by this section be fixed below twelve hundred (1,200) dollars.

Section 10.—All laws or parts of laws in conflict with this Act are hereby repealed.

AN ACT

TO CORRECT SEVERAL ERRORS EXISTING IN THE TEXT OF VARIOUS ACTS APPROVED DURING THE SECOND SESSION OF THE FIFTH LEGISLATIVE ASSEMBLY OF PORTO RICO.

Be it enacted by the Legislative Assembly of Porto Rico:

Section 1.—The following modifications are hereby made in Section 1 of an Act approved March 10, 1910, entitled: "An Act to amend 'An Act to amend Title IX of the Political Code' and an Act entitled 'An Act to amend Chapter II Title IX of the Political Code, and to repeal certain sections of the Penal Code, and for other purposes,' approved March 9, 1905; Sections 1824 and 1825 of the Civil Code and Section 218 of the Mortgage Law, and for other purposes, approved March 14, 1907."

In the first line of said section, both in the English and the Spanish text, to strike out the number "3" and insert in its stead the number "17". In the eighth line of the English text of same section, to strike out the word "amended" and insert in its stead the word "approved".

Section 2.—The following modifications are hereby made in the English text of the Act approved March 10, 1910, entitled "An Act to provide for contracts of advances for agricultural purposes and grinding of cane, and for other purposes:"

In Section 5, seventh line, to strike out the word "and", between the words "manufacture" and "sale", inserting in its stead the word "or".

In Section 6, seventh line, to strike out the words "for
